# How to Identify PACIFIC STEEL<sup>™</sup> Products

Our bar markings assist builders, specifiers and inspectors in identifying our products as being New Zealand made product, produced by Pacific Steel (NZ) Ltd to AS/NZS 4671. To ensure all the steel on your site is made by Pacific Steel, to our local standards, be sure to look for either our 'PACIFIC<sup>™</sup> brand or the Dot/Dash combinations.

### **Grade Markings**

Our unique bar markings allow users to quickly identify if their product is a PACIFIC STEEL<sup>™</sup> grade 300E or 500E product:

- » Deformed 500E products have '500E' rolled into the bar, two longitudinal ribs and a missing transverse rib before the 'PACIFIC'<sup>™</sup> mill mark.
- » **Plain 500E** products have a dot and two dashes rolled into the bar.
- » Deformed 300E products have '300E' rolled into the bar and two longitudinal ribs before the 'PACIFIC' mark.
- » Plain 300E products have two dots rolled into the bar


### Mill Markings

All PACIFIC STEEL<sup>™</sup> grade 500E and 300E products by Pacific Steel are rolled with our unique mill bar markings to assist in identification on site:

- » **Deformed bars or coils** have our mill mark, 'PACIFIC<sup>™</sup>, rolled into the bar surface.
- » Plain bars/coils (as typically used by mesh manufacturers) have either 2 Dots, or a Dot and 2 Dashes.

### **REIDBAR™** Markings

All PACIFIC STEEL<sup>™</sup> grade 500E REIDBAR<sup>™</sup> products are rolled with a short transverse rib on one side of the bar in accordance with the AS/NZS 4671 standard.



**IMPORTANT NOTE:** In line with our reinforcing brand update to PACIFIC STEEL<sup>™</sup>, the historical 'SEISMIC'® bar marking updated to 'PACIFIC<sup>™</sup> from June 2024. SEISMIC® continues to be a registered trademark of Pacific Steel (NZ) Ltd, and 300E/500E products featuring the former bar marking may still be observed in the market during this transition and treated as compliant.
